Sealed Bids will be received by Village of Sussex at N64 W23760 Main Street, Sussex, WI 53089 no later than 2:00 p.m. local time on February 22, 2012. Bids will be publicly opened and read aloud at the above time and place.

Project involves work in 6 different locations throughout the Village of Sussex. The work includes approximately 740 feet of sidewalk, 210 square yards of concrete road removal and replacement, 60 feet of concrete curb and gutter, 10 square feet of concrete driveway apron removal and replacement and miscellaneous structural adjustments.

If the successful Bidder fails to execute the contract and furnish payment and performance bonds within 15 days after the award, the Check or Bid Bond shall be forfeited to the Village of Sussex as liquidated damages.
